NOW, THEREFORE, for and in consideration of the covenants, conditions and restrictions contained in the aforesaid Declaration and herein, and for and in consideration of the premises, the Undersigned do hereby modify and amend the above described Declaration as follows:

- 1. Paragraph 3 of the above described Declaration shall be modified and amended in its entirety and said Paragraph 3 shall henceforth provide as follows:
 - 3. BUILDING CONSTRUCTION. All structures erected on the Lots in the Property in accordance with this Declaration shall meet the minimum requirements, specifications and standards of the Uniform Building Code or the HUD Code, or Uniform Building Code or HUD Code equivalents, as the same may be amended from time to time, and as the same may be interpretted and enforced at the applicable time by the City of Rock Springs. All structures erected on the Lots in the Property in accordance with this Declaration, whether intended for residential, accessory or other purposes, shall be of a permanent and affixed nature and shall be of a quality consistent with the other structures located on the Lots in the Property and the general construction standards in the industry in Sweetwater County, Wyoming. No structures of a temporary character, including, but not limited to, motor homes, mobile homes, trailers, tents or similar units, shall be used for residential purposes at any time.
- 2. Other than as expressly set forth herein, all of the other terms and provisions set forth in the above described. Declaration shall be and remain in full force and effect as originally stated in said Declaration.
