Whereas, Declarant desires to amend the provisions of Article I, Section47 and Article III, Section 38 of the Declaration relating to Assessments for Single Family Services, in order to clarify the services provided by the Association for just the Owners of the Single Family Lots.

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Project and the Lot Owners thereof, Declarant hereby executes this First Amendment to Declaration of Covenants, Conditions, and Restrictions for Morningside at Rock Springs, a Planned Unit Development.

1. Article I, Section 47 of the Declaration shall be replaced with the following language:

Single Family Services shall mean services that may be provided by the Association to just Single Family Lot Owners by the Association. If the Association determines to provide Single Family Services, expenses for the services shall be assessed to Single Family Lot Owners as part of their assessment.

2. Article III, Section 38 of the Declaration shall be replaced with the following language:

Assessments for Single Family Services. The Association may provide certain services that benefit only the Owners of Single Family Lots. In the event, the Association determines to provide Single Family Services; each Single Family Lot Owner shall be liable for an equal share of the Expenses incurred by the Association for services provided exclusively for Single Family Lot Owners.

3. The effective date of this Amendment is the date it is recorded in the office of the County Recorder of Sweetwater County, Wyoming.


